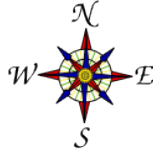

The survey will be conducted with reasonable care and due diligence with a hands on and visual survey of all accessible areas of the vessel. The vessel will be surveyed without removal of any fittings, tacked carpet, screwed or nailed boards, fixed partitions, anchors, chain, or other fixed or semi fixed items. The owner is advised to open and make accessible all areas of the vessel.

The surveyor will not operate any machinery or equipment without the presence of the owner or the owners representative. Engine and machinery should be surveyed separately by a qualified engine surveyor.

The spars and standing rigging are inspected from the deck only. Beyond visual inspecting of rigging, customer is advised to consult with rigging surveyors.

The surveyor will make neither weight calculations nor measurements. All dimensions and weights are from published specifications. All recommendations and remarks will be expressions of the surveyor based on experience, skill and training. No part of the survey report will issued as an expressed or implied warranty or guarantee of the vessels condition, value and replacement cost.

Acceptance and use of this report by the client acknowledges the client's understanding that the report has been composed of information that is believed to be true after reasonable investigation and inquiry but is not warranted to be so. The information was obtained without drilling, diving, ultrasonics, cleaning or opening up to expose parts or conditions ordinarily concealed. There were no tests for tightness or soundness conducted other than the conditions noted visually.
